There have been reports of retailers not accepting status cards at point of sale for the 8% tax exemption. They are being non compliant and need to be reported to the Ministry of Finance. If this should happen to you note the date, retailers name, address if possible, phone number of store. Ask to speak with the manager and get his/her name and get the reason they are not honouring the status card.

You can let them know you will be filing a complaint to the Ministry of Finance.

The General Inquiry line is an automated system, so when directed say file a complaint and the system will direct you to a Service Representative.

The training scheduled for October 16 and 17 has been Re-scheduled to November 13 and 14 and will be held in the band office boardroom. The prerequisite of IMS 100 must be completed prior to this training. We need a minimum of 8 participants.

We are looking for participants who would like to receive training designed to teach you the basic functions, concepts, and principles of the Incident Management System. IMS 200 is a 1.5 day training that can be applied to your everyday life. Lunch will be provided. You will need to take the online IMS 100 course before taking IMS 200.

The training is beneficial for everyone, especially occupations that are more likely to face emergency situations such as:

- fire fighters
- police officers
- event organizers
- leadership
- service providers
- nurses; PSW's; paramedics
- crisis coordinators
- and more!

The Incident Management System (IMS) is a standardized approach to emergency management encompassing personnel, facilities, equipment, procedures, and communications operating within a common organizational structure. The IMS is predicated on the understanding that in any and every incident, there are certain management functions that must be carried out regardless of the number of persons who are available or involved in the emergency response.

Job Summary

The Red Rock Indian Band is seeking a highly motivated individual to fill the position of Director of Lands and Resources. Reporting to the Chief and Council, the Director, Lands and Resources ensures that any government or business venture operating within the Red Rock Indian Band Traditional Area meets their duty consult. The Director of Lands and Resources will be responsible for the overall protection, management and reporting related to the Red Rock Indian Band's natural environment, including the protection of water quality, land resources, fisheries and wildlife habitat, cultural and heritage resources relevant legislation, regulations, directives, policies and procedures.

Job Duties

- Manage the preparation, negotiation, interpretation and implementation of agreements and contracts as they relate to the Red Rock Indian Band, Government, and other First Nations and Trans-boundary agreements
- Liaising between the People of the Red Rock Indian Band, Chief and Council, Government, and Industry on Lands and Resources Related Matters.
- Facilitating the permitting process while leading consultations & overseeing all issues as they relate to Land, Resources and Environment
- Oversee and assist with environmental audits ensuring they are continuously completed in order to minimize undesirable environmental effects of new or expanded operations within the Red Rock Indian Band's Traditional Territory.
- Planning, measuring, reviewing, implementing, and managing all Land, Resources and Environmental activities
- Ensure employees have clear goals and are aware of expectations
- Coordinate activities by scheduling work assignments, setting priorities, and delegating work accordingly
- Ensure that safe work practices are being followed
- Ensure that employees adhere to all health and safety regulations
- Provide leadership for employee relations through effective communications, coaching, training, and development
- Analyse departmental operations and identify areas requiring improvement
- Plan the department's workload and flow
- Evaluate employee performance and provide feedback, coaching, and formal evaluations

Job Requirements

- Degree or a combination of education and on the job experience in a field relating to the energy and natural resources industry considered an asset
- Certifications or licences appropriate to the energy and natural resources industry are preferred
- Ability to plan, organize, develop, implement, and interpret goals, objectives, and policies
- Strong formal and informal leadership skills
- Ability to identify issues and implement creative and strategic solutions to overcome problems
- Ability to remain calm and poised in urgent situations
- Ability to supervise and motivate a team to achieve and exceed their goals
- Effective leadership skills, with a strong focus on mentoring and motivation of employees
- Demonstrated project management skills

Work Conditions

- Flexible hours, including nights, weekends, and holidays
- Interaction with employees, management, and the public at large
- Operation of desktop computer and peripherals

Since this position is engaged primarily in serving the interests of Aboriginal people, The Red Rock Indian Band shall give preference to Aboriginal people who possess the requisite skill sets and experience.

Have your ID ready to vote

Three options to prove your identity and address

Option 1



Show one of these pieces of ID

- your driver's licence
- any other card issued by a Canadian government (federal, provincial/territorial or local) with your photo, name and current address

Option 2

Show two pieces of ID

Both must have your name and at least one must have your current address

Examples:

- voter information card and bank statement
- utility bill and student ID card

Don't have these? No problem!

If you don't have ID

You can still vote if you declare your identity and address in writing and have someone who knows you and who is assigned to your polling station vouch for you.

The voucher must be able to prove their identity and address. A person can vouch for only one person (except in long-term care institutions).

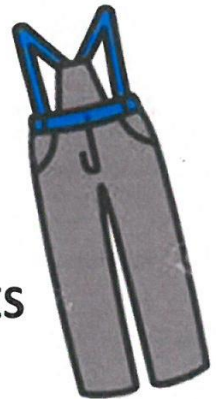
Many families have a difficult time making ends meet and simply don't have the means to purchase the clothing needed to stay warm.

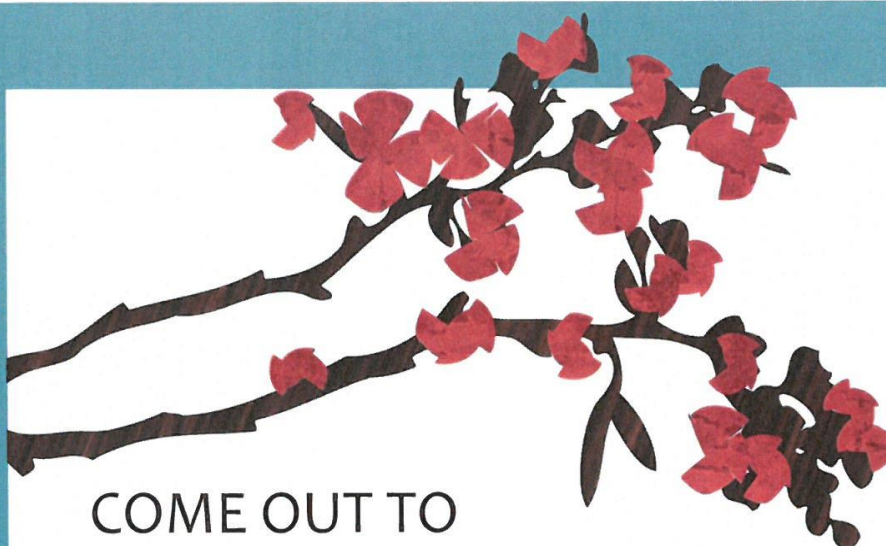

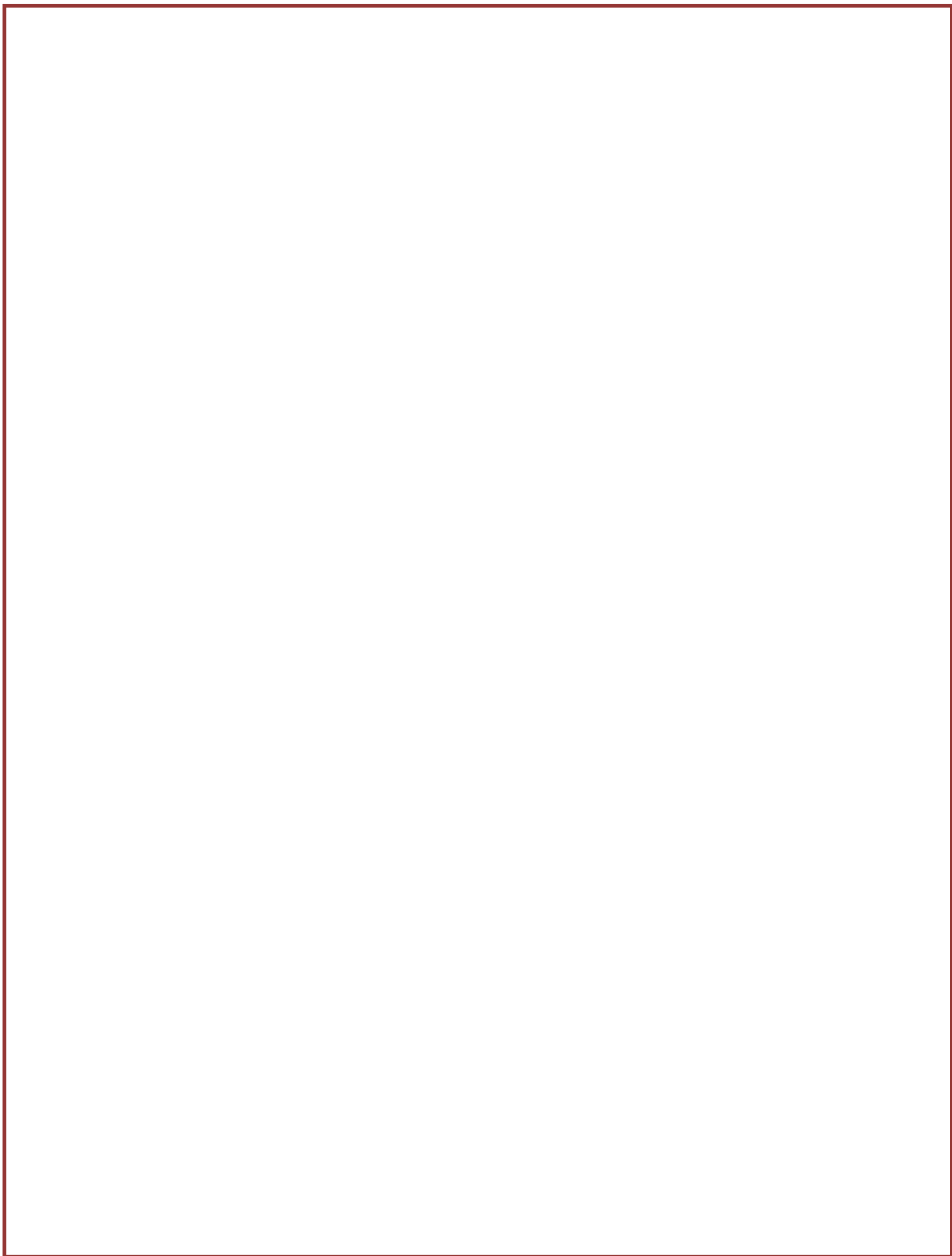

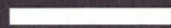

Do you know of community members or youth planning to undertake work in this area?

The Canada Ontario Resource Development Agreement (CORDA) Office is now accepting funding applications for 2020-2021.

Eligible project categories include:

- ✓ Forestry
- ✓ Trapping
- ✓ Fishing
- ✓ Other*

** Examples include rice harvesting, eco-tourism, and maple syrup production.*

Projects may include training such as a youth trapper courses, employment, stewardship, traditional learning, equipment (such as humane traps), and supplies (such as trees for planting).

The Canada Ontario Resource Development Agreement (CORDA) is an agreement between Canada, Ontario and First Nations' members in Ontario.

The Agreement promotes resource and economic development initiatives of First Nations' members by providing financial assistance to develop and utilize sustainable natural resources.

First Nations, their members and organizations, and Treaty organizations in Ontario are eligible to apply for funding.

The maximum funding level for projects is \$35,000 per year.

CORDA is funded by Indigenous Services Canada and the Ontario Ministry of Natural Resources and Forestry.
