NNADAP Position Job Description

Reports to: Mental Wellness Services Manager

Background: National Native Alcohol & Drug Abuse Program (NNADAP) offers services and activities that aim to support individuals dealing with substance use, as well as to reduce and prevent alcohol and drug addiction.

Primary duties & responsibilities:

- Primary contact for Lake Helen Reserve and Red Rock Indian Band members 18+ seeking treatment and support for substance use and addictions.
- Provide case management and/or counselling to support service users facing various challenges related to substance use and addictions
- Responsible for providing culturally relevant prevention, intervention, and/or aftercare education and awareness activities that fall under the National Native Alcohol & Drug Abuse Program for the community.
- Working with individuals to develop a personalised support plan, implementing tailored interventions that promote independence and overall wellbeing, and followup of the client goal plan
- Recommend and connect them to external services and supports
- Provide crisis intervention with health and safety concerns when it is determined that additional intervention is required
- Maintain current progress records and documentation
- Develop and oversee aftercare programs designed to help individuals adapt to daily life, maintain sobriety, and address potential challenges after they've left a structured treatment program to support them in their recovery journey.
- Integral part of a crisis response team to respond to social crises in the community and provide crisis interventions. Interventions can be supporting one-on-one, family and/or community whenever necessary.
- Provide debriefing to individuals/groups/families/staff after a critical incident
- Partner with mental health staff in delivering programs & training related to mental health promotion, harm reduction, cultural, and trauma-informed care.
- Collaboration and teamwork working closely with other mental health staff

Job Requirements:

- Post-secondary education related to mental health and addictions, health or human services field and a minimum of one year experience preferably in a First Nation community or Indigenous organization. Lived experiences would also be a consideration.
- Registered with a counselling certification board an asset

- Mental Health First Aid, SafeTALK, A.S.I.S.T., Critical Incident Stress Management and/or Psychological First Aid certification would be assets
- Applicants should demonstrate a good knowledge of trauma-informed care, community addiction and mental health services and resources
- Applicants should demonstrate a willingness to learn and actively participate in training related to addictions, mental health and harm reduction
- Must be dependable, have excellent organizational, problem-solving, empathy and active listening skills and an ability to communicate professionally with community agencies
- Ability to manage conflict and crisis situations
- Ability to work outside regular office hours when required (evening, occasional weekends)
- Valid Ontario "G" Driver's License, access to a reliable vehicle and proof of \$2,000,000 liability insurance

Working Conditions:

- Moderate physical efforts may be required
- Travel within and outside the community required
- Requires the ability to work in a team-oriented environment and minimal supervision
