



Natural Gas 101

- Our customers are currently paying the lowest natural gas costs in the province








Cost Comparison

What is the OEB?



- The Ontario Energy Board (OEB) is an independent regulatory body which has jurisdiction over production, distribution, transmission and storage of natural gas in Ontario
- OEB approves natural gas rates quarterly
- Within Union Gas' regulatory framework, existing customers can not subsidize the costs of new customers
- Other utilities operate under a different regulatory framework
- Economic model is approved by the OEB
- OEB sets specific metrics we need to achieve

Community Expansion: Timeline



2014

• The Ontario government first indicated it would commit funding, \$30 million in grants and \$200 million in interest free loans, to support expansion of natural gas infrastructure to rural and northern communities and first nations

2015

- •The OEB asks gas utilities to submit proposals for regulatory flexibility to support community expansion to rural and remote communities
- •Union Gas is the first, and only, gas utility to submit an application for regulatory flexibility with a proposal to serve up to 30 new communities

2016

- The OEB suspends hearings on Union Gas' community expansion proposal and announces a generic hearing to decide on a new framework for community expansion
- OEB conducts generic hearings Union Gas actively champions our proposal
- OEB issues decision on generic hearings, granting some regulatory flexibility. Our proposal is not approved

2017

- Union Gas completed a thorough review of the OEB decision
- The Ontario Government announces \$100 million in grants to help move projects forward.
- In March we filed our first application for expansion to the OEB

OEB Decision

Minimum Profitability Index (PI)	0.40	1.0
Temporary Expansion Surcharge (TES)*	\$0.23 per m ³	Special Project Rates; a surcharge mechanism is also allowable
Incremental Tax Equivalent (ITE)*	Required to reduce PI to 0.40. Otherwise PI is 0.80.	Voluntary

^{*} Union proposed a surcharge term of a minimum of 4 years to a maximum of 10 years.







Ontario's Natural Gas Grant Program



The Program:

- Ontario is helping to expand access to natural gas across the province
- \$100m grant program for municipalities, First Nations and unincorporated areas
- \$70m for community expansion; \$30m for economic development opportunities
- Applications to be submitted by natural gas distributor
- Cost of converting equipment and connecting individual properties are not eligible for coverage







Partnering on Grant Application



Our Commitment to Red Rock First Nation:

- Union Gas would submit grant application with relevant data
- If successful, Union Gas would submit the project to the Ontario Energy Board for final approval

What We Need From Red Rock First Nation:

- Demonstration of support for project via a Band Council Resolution
- Make a financial contribution towards project costs
 - Contribution must be equivalent to Payment in Lieu of Tax recovered from new natural gas infrastructure over ten-year period

Community Profile



What would expansion look like?

Customer Volumetric Surcharge Rate: \$0.23/m³

(approx. \$500 annually per average customer over an existing customer)

Surcharge Term: TBD years

First Nation: \$TBD equivalent to the incremental increase in Payment in Lieu of Taxes for minimum of 10 years (as per grant requirements)

Government Aid: \$TBC – Union Gas will submit this amount to the Provincial government

Timing: 2019 at the earliest pending approvals

Current Taxes paid by Union: IF APPLICABLE
