Community Volunteer Income Tax Program (CVITP)- FREE Income Tax Preparation

The CVITP is a collaboration between community organizations and the Canada Revenue Agency (CRA).

Community organizations host FREE tax preparation clinics and arrange for volunteers to prepare returns for individuals with a modest income and a simple tax situation. The CRA provides coordinators to guide the organizations as they deliver the program and offers training and tax software for the volunteers.

The CVITP helps people meet their tax obligations and receive any benefits to which they are entitled. Benefits are calculated based on the information a taxpayer provides on their return. Even if the taxpayer has no income to report, they should file a return to continue receiving payments, such as;

- GST/HST credit
- Guaranteed income supplement (GIS)
- Canada Worker's Benefit (CWB) this replaces the Working income tax benefit (WITB)
- Canada child tax benefit (CCTB) (if the taxpayer has a spouse or common-law partner, they also must file a return every year)
- Provincial or territorial credits and benefits

The CVITP volunteers **cannot** prepare returns for individuals who:

- have self-employment income
- have business or rental income and expenses
- have capital gains or losses
- have employment expenses
- file for bankruptcy
- are deceased in the year



IF THE WATER IS NOT CLEAR WHEN TAP IS TURNED ON, LET TAP RUN UNTIL WATER BECOMES CLEAR.

AS FOR THE HIGHER THAN USUAL CHLORINE IN THE WATER, FILL A PITCHER FULL OF WATER AND LET STAND ON COUNTER OR IN DIRECT SUNLIGHT. THIS WILL LESSEN THE CHLORINE BY QUITE A BIT.





COVID-19 BOOSTER



WHO should get a spring dose:

- **Indigenous adults 55 & older or their non-Indigenous household members who are 55 & older**
- **Adults 65 years and older**
- **Residents of senior congregate living settings**
- **Anyone 6 months & older who are immunocompromised**

WHEN to get a spring dose if eligible:

- **6 months after your last dose or COVID-19 infection**

HOW to get a spring dose if eligible:

- **Contact the Community Health Nurse at (807) 632-0589 to book an appointment**

MEASLES

NOT JUST A DISEASE FROM THE PAST

- Cases of measles have been reported in Ontario
- Measles is very contagious, it infects 90% of close contacts who are not immune
- Measles virus can live in the air and on surfaces for 2 hours
- Measles can cause serious health complications and death

SIGNS & SYMPTOMS

- High fever
- Cough
- Runny nose
- Red, watery eyes
- Small, white spots inside the mouth
- Rash starting 3-5 days after symptoms begin



If you have symptoms of measles, self-isolate and contact your healthcare provider for assessment. Make sure you phone ahead to protect others.





DOG CONTROL BY-LAW

A By-Law to regulate the keeping of dogs within the Lake Helen Reserve and to provide for fixing, imposing, prosecuting and collecting license fees and fines and the issuance of licenses to persons who own, possess, or harbour dogs.

1. INTRODUCTION:

This by-law may be referred to as the "Dog Control By-law". This by-law supersedes any other dog by-law which may be in place for Red Rock Indian Band.

2. DEFINITIONS:

- 2.1 "Band" means Red Rock Indian Band.
- 2.2 "Dog Catcher" includes the individual who has entered into a contract with the "Band" to control dogs.
- 2.3 "Dog" means any dog over the age of 4 months.
- 2.4 "Owner" of a dog includes a person who possesses or harbours a dog. ("owns" and "owned" have corresponding meanings).
- 2.5 "May" shall be construed as permissive.
- 2.6 "Shall" shall be construed as imperative.

3. DOG REGISTRATION AND LICENSING

- 3.1 Every dog owner shall register their dog with the Red Rock Indian Band and procure a license and dog tag for each dog owned by him/her. Dog licensing and tags shall be purchased on or before the 31st day of January in each and every year upon becoming the owner of a dog.

3.2 The license fee payable annually by the owner of a dog shall be:

Per Dog (male or female)	\$20.00
Per Dog owned by person 60 yrs or over	\$10.00
Spayed or Neutered Dog	\$10.00
Guide Dog for the blind	\$00.00

3.3 Every dog tag shall bear the serial number and the year in which it was issued. A record shall be kept by the Administration of Red Rock Indian Band showing the name and address of the owner, the breed of dog, dog's name and the serial number of the tag.

3.4 The tag shall be affixed to the collar on the dog and shall remain so affixed until a tag for a subsequent year is obtained and affixed.

3.5 Any tag issued under this by-law shall be used ONLY for the dog which the license was obtained and the tag shall not be transferred to any other dog.

3.6 Tags and licenses shall be transferred to any new owner of a registered dog. The new owner shall pay a transfer fee of \$5.00.

3.7 Transfers must be made by the new owner within fifteen (15) days. Failure to do so may result in a fine of \$50.00.

3.8 The replacement fee for a lost dog tag shall be \$5.00

3.9 A new resident of the Lake Helen Reserve must register his/her own dog within fifteen (15) days.

3.10 Every license shall be for one year and expire on December 31st of the same year.

4. RESTRICTIONS

4.1 The maximum number of dogs which can be kept or harboured per household is two (2). Exception: If a person owns 3 dogs when this by-law comes into effect, that person will be allowed to keep all the dogs until the exceeded limit expires.

4.2 Section 4.1 does not apply to:

- a) dogs under the age of 4 months
- b) the operation of a licensed kennel
- c) an animal hospital owned and operated by a veterinarian licensed by the Ontario Veterinarian Association
- d) a pet store
- e) dog sled teams

4.3 No person shall keep their dog in an unclean area.

4.4 No person shall keep any land, kennel, pen or enclosure in an unclean condition.

4.5 For the purposes of sections 4.3 and 4.4, an area is unclean when there is an accumulation of dog fecal matter, or an unpleasant odour.

5. CONTROL OF DOGS

5.1 No dog owner shall allow their dog to run at large, or trespass on aforesaid lands occupied by a band member within the boundaries of Lake Helen reserve.

5.2 For the purpose of this by-law, a dog shall be deemed to be running at large when found in any place other than the lands and premises of the owner of the dog and not under the control of any person.

5.3 A dog shall not be considered to be running at large if it is a guide dog or a police work dog or if it is a hunting dog accompanied by the owner and is actively engaged in hunting or training for hunting, on unposted land, or on posted land and with the permission of the owner.

5.4 No owner shall allow his/her dog to be in a public place at any time unless the dog is on a leash which shall be no longer than six feet and such leash is held by the dog owner.

5.5 No dog owner shall allow his/her dog in any area normally used by the public as a swimming area during the months of May, June, July, August and September inclusive.

- 5.6** Every dog owner shall remove forthwith any excrement left by his dog on lands occupied by a band member, without the consent of the owner of the premises or in a public place, and dispose of it in a sanitary way.
- 5.7** The Red Rock Indian Band Dog Catcher may seize any dog found running at large.
- 5.8** The Dog Catcher may enter on any public property or on lands occupied by a band member with the consent of the owner of the property, for the purpose of catching any dog running at large. Every dog seized shall be claimed by the owner or keeper of the dog.
- 5.9** Any person may capture any dog running at large and trespassing on his property and deliver to the Dog Catcher.
- 5.10** Where a dog is injured before, during or after being captured or taken into custody, or should be destroyed without delay for humane reasons or for reasons of safety to persons or animals, the Dog Catcher may kill the dog in a humane manner without permitting any person to reclaim the dog or without offering it for sale, and in that event no damages or compensation shall be recoverable on account of its killing. No dog shall be left to suffer.
- 5.11** Should it become necessary to put the dog down, every effort should be made to notify the owner
- 5.12** Every dog that has been picked up by the dog catcher shall be claimed by the dog owner within seventy-two (72) hours.
- 5.13** No dog will be left unattended for more than 24 hours.
- 5.14** Where a dog is claimed, the owner shall pay a fee of \$75 to the Red Rock Indian Band.
- 5.15** Where a dog is NOT claimed after seventy-two (72) hours the dog catcher will detain the dog for such time as he may consider proper. During that time he may find a home for the dog or kill the dog in a humane (as defined by the humane society) manner or dispose of the dog as he sees fit.

6. DANGEROUS DOGS

6.1 Dangerous Dog, means any individual dog (including full and mixed breeds) that:

- (a)** has killed a domestic animal without provocation while off the owner's property;
- (b)** that has attacked a human being or domestic animal without provocation;
- (c)** has bitten or injured a human being or domestic animal without provocation on public land or lands occupied by a band member;
- (d)** is attack trained;
- (e)** shows the disposition or tendency to be threatening or aggressive.

6.2 Any dog who has bitten or attacked any person or domestic animal, or is known to have bitten or attacked any person or domestic animal will not be tolerated.

6.3 Notwithstanding the provisions of paragraph 6.1, the following breeds of dogs are deemed to be dangerous and are banned from Lake Helen Reserve:

- (1)** Pitt Bulls;
- (2)** Rottweilers;
- (3)** Staffordshire Terriers;
- (4)** Bull Mastiffs; and
- (5)** Doberman Pinschers,

6.4 For the purpose of this by-law, Lake Helen Reserve includes all land owned by the Red Rock Indian Band.

6.5 Visitors of Lake Helen with such breeds (as outlined in 6.1 & 6.3) of dogs, either as pets, guard dogs or for breeding purposes, will immediately remove these dogs from Lake Helen.

7. OFFENCES AND PENALTIES

7.1 Every person who violates any of the provisions of this By-law, or who suffers or permits any act or thing to be done in contravention of any of

the provisions of this By-law, or who neglects to do, or refrains from doing, anything required to be done by any of the provisions of this By-law, or who does any act which violates any of the provisions of this By-law, will be guilty of an infraction and will be liable to the penalties imposed by the By-law.

- 7.2 A person who violates any of the provisions of this By-law will upon summary conviction be liable to a penalty of not more than \$1,000 plus the costs of the prosecution payable to the Red Rock Indian Band.


8. COMPREHENSIVE CODE

- 8.1 The provisions of this By-law are a comprehensive code and an exclusive regime concerning the regulation for the keeping of dogs within the Lake Helen Reserve and the provision for the fixing, imposition, prosecution, and collection of license fees and fines and the issuance of licenses to persons who own, possess, or harbour dogs.
- 8.2 The provisions of this By-law shall prevail over any other general or special legislation, regulation, or By-law concerning the same whether enacted federally, provincially, or municipally.
